#### **Application Procedure:**

Complete and submit the application form - attached - to the Town Planner. This form includes the applicant's contact information, the requested grant amount, total estimated cost of the project, and a narrative of the purpose and benefit of the project to the Town. Grant matching is limited to 50% of the projected total cost with a maximum \$1,000 contribution by the Town.

All applications will be reviewed by the Town's Design Committee. Upon their decision, grant award recipients will recieve notice from the Town Planner in writing by the published award date. Paid receipts and reimbursement forms must be submitted to the Town Planner within 45 days of completing the project. This form will be sent to the Town Treasurer for processing. Reimbursement checks will be mailed directly to the applicants

- Conformance to character of surrounding area/compliance with regulations
